- 2.1. **Contact & Account Data:** Name, company, email address, phone number, billing address.
- 2.2. **Project Data:** Site addresses, flight plans, hazard notifications, parking instructions.
- 2.3. **Imagery & Sensor Data:** Photos, video, LiDAR point clouds, multispectral maps generated during flight.
- 2.4. **Usage Data:** Website interaction logs, portal download activity, support inquiries.

## **3. How We Use Your Information**

- 3.1. **Service Delivery:** Plan and conduct safe, compliant flights; process and deliver imagery and reports.
- 3.2. **Communications:** Send quotes, invoices, project updates, and support responses.
- 3.3. **Marketing & Promotion:** With your express permission, we reserve the right to feature project photos and data on our website and in promotional materials.
- 3.4. **Quality Improvement:** Analyze project outcomes (via After-Action Reports) to refine workflows and technology choices.
- 3.5. **Legal & Safety Compliance:** Maintain flight and vehicle records to satisfy FAA, local permitting agencies, and insurance requirement

## **4. Data Sharing & Disclosure**

- 4.1. **With Your Consent:** We may share data with partners or subcontractors (e.g., processing labs) strictly to fulfill your project
- 4.2. **Service Providers:** Cloud hosting, mapping software vendors (e.g., Pix4D, DroneDeploy, AirData UAV) only receive raw sensor data to deliver their services.
- 4.3. **Legal Obligations:** We may disclose data only if required by law, regulation, or valid subpoena; Information will be limited to only requested parameters.
- 4.4. **Business Transfers:** In the event of a merger or sale, your data may transfer to the acquiring entity under the same privacy commitments. If the acquiring entity is unable or unwilling to uphold those commitments, we will delete your information and notify you when possible

- 4.5. **No Sale of Personal Data:** We will never sell, rent, or trade your personal information to any third party
- 

**5. Data Retention & Access**

- 5.1. **Retention:** We archive project files and After-Action Reports for a minimum of five years to support compliance audits, repeat engagements, and training of FloSight employees or trainees.

- 6.1. **Technical Controls:** AES-256 encryption in transit and at rest; multi-factor authentication for internal portal access.
- 6.2. **Administrative Controls:** Role-based access, regular security audits, and staff education on personal data handling.
- 6.3. **Physical Controls:** Secure office network and locked file storage in home
